DIASPORIC IDENTITY AND CULTURAL ALIENATION IN NAIPAUL'S FICTION: A COMPARATIVE STUDY OF THE MIMIC MEN, A HOUSE FOR MR BISWAS, AND HALF A LIFE

ABSTRACT

The themes of diasporic identity and cultural alienation, as explored in the novels *The Mimic Men*, *A House for Mr Biswas* and *Half a Life* by V. S. Naipaul are discussed in this study. This study is qualitative and comparative in nature and the intention was to explore issues and concerns of Naipaul's depiction of themes of displacement, crisis of identity, cultural hybridity and alienation of individuals between cultures. The study takes its starting point in postcolonial and diasporic theories and explores how the protagonists attempt to create a feeling of belonging in postcolonial and migratory societies. colonialism and who are migrants or globalized citizens. V.S Naipaul is a well known author who has written extensively on these issues. Naipaul's life, in which he was born to an Indian immigrant family and raised in England, has been influenced by a variety of cultural factors and experiences of displacement. His literary works are frequently concerned with the dilemmas of identity formation in postcolonial societies, the characters in which are at "between cultures", between finding a unified sense of self or not. Naipaul's focus is always on colonial history, migration and cultural history, with him being a leader of the discourse on diaspora and identity.

In his novels, Naipaul has repeatedly documented the protagonists' experiences of extreme rootlessness and alienation. It's characters that are used outside their own culture, and outside the cultural setting that is accepted by any of their own cultures. As a result, they have a constant "doubleness" in their identity, social status and cultural identity. Exile, mimicry, hybridity and displacement are themes that run throughout Naipaul's work, and reflect his complexities in living in multiple cultural worlds. Likewise, *Half a Life* has a story of a fragmented identity, Willie Chandran, who traverses India, Africa and Europe in a quest for meaning, definition. King examines the personal and cultural and historical factors that have influenced Naipaul's writing, especially his experience as a Trinidadian of Indian descent, raised in Britain. The subjects of displacement, alienation, colonial legacy and identity crisis that run through Naipaul's fiction are all brought to the fore in this study. King contends that Naipaul's fiction is

infused with his personal experiences with cultural hybridity and diasporic consciousness, and thus holds significant insights for the complexities of the postcolonial subject and consciousness.

Kaur (2023), In her article Post Colonial Review of VS Naipaul's Fiction, critically analyses Naipaul's novels from postcolonial perspective. The author examines the ways Naipaul depicts the socio-cultural and psychological effects of colonization on society's post-colonial state. Kaur argues that Naipaul's works expose the multiple selves of postcolonial persons and their efforts to reconcile with their indigenous identity and the values imposed by the colonisers. Themes of cultural dislocation, mimicry and identity crisis are crucial to Naipaul's narrative technique, and are crucial to postcolonial discourse, the study further shows.

Bhuiyan (2019), This study Diaspora Identities and Psychic Trauma in VS Naipaul's A House for Mr. Biswas and The Mimic Men: A Postcolonial Perspective focuses on the link between diasporic identity and psychological trauma in the chosen fiction of VS Naipaul. The author is a post colonialist and states that the characters have been deeply alienated from their homeland, are homeless and have existential anxieties because of the circumstances they are in. The study reveals how colonial pasts and migration pasts affect characters' sense of self, leading to ongoing identities struggles and psychic suffering. Naipaul's complex physical and emotional dislocations and diasporic subjectivity are especially noteworthy features of the study.

Kalsoom and Karim (2014), Using the theory of dialogism in the work of Bakhtin, discuss in their article the discourse of crossing the border and cultural interaction is Bakhtin's Dialogic Analytical and Naipaul's Crossing the Border. The authors contend that Naipaul's writings have several registers, and several points of view, which reflect the complex nature of migration, identity and cultural negotiation. The study uses dialogic analysis as a method to show how Naipaul depicts cultural encounters as a process, not a reality, of contestation. The research shows that Naipaul's writings feature heteroglossia and polyphony which enrich the understanding of his literary style and thematic investigations.

Giri (2019), Home and Away: Migrancy, Diasporicity and Identity in Select Novels of VS Naipaul examines the themes of migration, diaspora and identity in the Naipaul's fiction. Giri claims that Naipaul's main characters frequently seek dual identity and roots in a "foreign country." The study shows that the migration process fosters feelings of disconnection and cultural liminality, forcing migrants to navigate a number of identities. Moreover, the author emphasizes that the ideas of home and exile continue to be central to the comprehension of the diasporic experiences that are represented in Naipaul's novels.

Chemnchu (2025), Aesthetics, Migration and Cultural Transformations in V. S. Naipaul's Half a Life and The Mimic Men looks at the aesthetic elements of migration and cultural transformation in Naipaul's selected works. The writer sees migration as a geographical movement but also a "transformation process" that alters the identity and cultural affiliations of individuals. The study shows that Naipaul's characters experience tremendous personal and cultural change in the contexts of varying societies and politics. Chemnchu also suggests that Naipaul develops complex techniques to portray the complexities of 'hybridity', 'displacement' and 'cultural adaptation' in a globalised world.

RESEARCH METHODOLOGY INTRODUCTION

In the present study, the issues of diasporic identity and cultural alienation in V. S. Naipaul's fiction will be the themes that will be discussed in the context of diasporic identity and cultural alienation in three important novels of V. S. 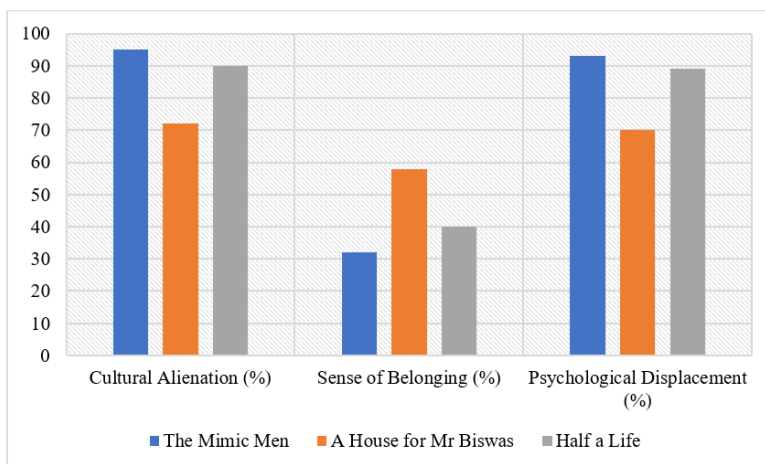
SEARCH FOR BELONGING AND SELFHOOD
